- Pastoral and program staff salaries are composed of a base salary as outlined in #2 plus supplements as outlined in #3 and #4.
   Congregations determine where incoming pastors and program staff are placed on the grid.
- Base Salary: \$47,651.
   This is an increase of 2% over the 2018 base salary
